## **General Update**

- Warren talked with Steve Elfstrand from MnSCU. They are running ILL for the University of Minnesota for probably another year. Many of the public libraries are not trying Evergreen, due to the expense of the system. Al Rykhus retired from MnSCU, their Oracle DBA, and went to work for ODIN. His position is still open at MnSCU. They are having a hard time getting any applicants for his position.
- The BOR recently completed a security audit for our network. There were no issues with the audit.

**FY14 YTD Budget** – The remaining or anticipated amount under personnel has changed due to Gary Johnson's salary and an increase in health insurance premiums. It was noted that the anticipated/remaining amount looks incorrect. An updated FY14 YTD will be sent out.

#### **Unfinished Business:**

**ALEPH v.22 Update** – Sean reported that he had not heard from Rick Chu, Florida Virtual Campus, for over 2 weeks, even after sending several follow-up messages. He did hear from him early yesterday and they are discussing fees. His other option, which would be a last resort, is Ex Libris. Sean is asking for a price quote from them. ALEPH v.23 is set to release in the fourth quarter of 2016 or the first quarter of 2017.

**SLiC Update**- Ronelle asked the committee if anyone has heard anything concerning the new MOU. Ronelle had talked with Dan Daily who told her that nothing was in the packets for the BOR meetings held the first of April. The meeting was abbreviated due to the threat of the upcoming storm. Daria called Melody last week asking for a copy of the new MOU and had not heard back from her. Daria said at the March 31<sup>st</sup> meeting with Jack, Sam and Melody that there was a lot of discussion but no decisions had been made. Sam had sent an email stating that they would not be able to meet before May 15, due to everyone's schedules.

**Review of SDLN Staff Positions**- Warren sent out an email on April 7 announcing the hiring of Gary Johnson. Warren has received many positive comments.
